

**INFORMATION NOTICE REGARDING PERSONAL DATA OBTAINED WITHIN THE

Within the scope of the Law No. 6698 on the Protection of Personal Data (the “**Law**”), as Aksoy Holding Anonim Şirketi (the “**Company**”), acting in the capacity of Data Controller, we would like to inform you about the personal data processed by us in the event that you submit a data subject application to the Company pursuant to Article 11 of the Law.

Processed Personal Data, Purposes of Processing Personal Data, Transferred Parties and Purposes of Transfer

The necessary administrative and technical measures are taken by our Company to ensure the security of your personal data.
